Subject:- Selection of candidates after operation of waiting list for the post of Sub Inspector in J&K Police Telecommunication Wing.

- Reference:- i) Selection list issued by PHQ vide order No. 147 of 2019 dated 10-01-2019.
ii) Director Police Telecommunication letter Nos. Estt/Apptt-SI/2018/7819 dated 17-10-2019 and 8701 dated 21-11-2019.

Whereas, in terms of PHQ order No.147 of 2019 dated 10-01-2019 selection list in favour of 40 candidates as Sub Inspectors in J&K Police Telecommunication Wing was issued after completion of Recruitment Process carried out in the year 2017-18 and were subsequently adjusted in Telecommunication Wing and directions were issued to Director Police Telecommunication J&K for issuance of their formal appointment orders subject to fulfillment of prescribed formalities.

Whereas, the selected candidates were advised to present themselves in the office of Director Police Telecommunication alongwith requisite testimonials for fulfillment of pre-requisite formalities prescribed for issuance of formal appointment orders within 21 days; and

Whereas, after the expiry of 21 days, directions were given to Director Police Telecommunication J&K to intimate the reporting/non reporting of selected candidates in their respective offices; and

Whereas, in response to PHQ directions, Director Police Telecommunication has intimated that 11 candidates have not reported within stipulated time frame for joining. These 11 candidates have further sworn in affidavit that they are not willing to join against the posts for which selected; and

Whereas, accordingly, the selection of said 11 selected candidates was cancelled vide PHQ order No. **4836** of 2019 dated **14**-12-2019 on the recommendation of Director Police Telecommunication vide his reference quoted above; and


Whereas, consequent upon the above and considering the vacancies accrued as a result of cancellation of selection of 11 candidates, the waiting list is operated for filling up of these resultant vacant posts in pursuance to SRO-202 of 2015 dated 30-06-2015; and

Whereas, a candidate namely Umer Jan S/o Gulzar Ahmad Najjar R/o Lajoor, Pulwama with D.O.B 27-03-1991 of OSC category having secured 64.73 marks was already selected under OSC category and while operating the waiting list under OM category, the said candidate having higher merit than the next candidate in OM category (namely Mubashir Moin S/o Gh. Rasool Ahanger having 64.51 marks), as such, Umer Jan jumped from OSC category to OM category causing one vacancy in OSC category which has been filled by selecting the candidate next in order of merit of OSC category; and

Now, therefore, taking into consideration the above facts, the candidates mentioned in annexure "A" of this order are hereby selected as Sub Inspector in J&K Police Telecommunication Wing from the waiting list subject to the fulfillment of following conditions/formalities:-

- i. Verification/authentication of the academic qualification certificates and other testimonials..
- ii. Verification of category certificate in respect of those candidates selected under respective categories in pursuance of SRO-294 of 2005 dated 21-10-2005 read with SRO 144 of 2008 dated 28-05-2008.
- iii. Verification of Character/antecedents from CID.
- iv. Medical examination/checkup from respective Police Hospital Kashmir/Jammu.

The candidates selected shall report to Director Police Telecommunication J&K alongwith their original testimonials within 21 days from the date of issuance of this order failing which their selection shall be deemed to have been cancelled abinitio.
