Subject: Selection of candidates after operation of waiting list for the post of Sub Inspector in J&K Executive/Armed Police.

Reference:- i) Selection list issued by PHQ vide order No. 6626 of 2018 dated 15-12-2018.

iii) ADGP Armed J&K, Zonal IsGP and DIG JKS Range Jammu Nos. APHQ/Pers/Not-rep/Not-Will/SIs/24/2019/30708-10 dated 21-10-2019, Estt/Rect-SI-18/2019/19538-39 dated 26-11-2019 & Pers/Rec-SI/2019/24946 dated 09-08-2019 and DIG JKS Range No. Estt/2019/16814-15 dated 25-10-2019.

PHQ Order No: 4839 of 2019 Dated: - 14 -12-2019

Whereas, in terms of PHQ order No.6626 of 2018 dated 15-12-2018 selection list in favour of 658 candidates as Sub Inspectors in J&K Executive/Armed Police was issued after completion of Recruitment Process carried out in the year 2017-18 and were subsequently adjusted in concerned Ranges and directions were issued to ADGP Armed, J&K, Zonal IsGP for issuance of their formal appointment orders subject to fulfillment of prescribed formalities.

Whereas, the selected candidates were advised to present themselves in the office of Range DsIG alongwith requisite testimonials for fulfillment of pre-requisite formalities prescribed for issuance of formal appointment orders within 21 days; and

Whereas, after the expiry of 21 days, directions were given to Zonal Heads to intimate the reporting/non reporting of selected candidates in their respective offices; and

Whereas, in response to PHQ directions, ADGP Armed, Zonal IsGP have intimated that 45 candidates are not willing/not reported within stipulated time frame for joining which indicates that these candidates are not interested to join the Police Department; and

Whereas, accordingly, the selection of such 45 selected candidates was cancelled vide PHQ order No. 4838 of 2019 dated 19-12-2019 on the recommendation of ADGP Armed and Zonal IsGP vide their references quoted above; and

Whereas, consequent upon the above and considering the vacancies accruing as a result of cancellation of selection of 45 candidates, the waiting list is operated for filling up of these resultant vacant posts in pursuance to SRO-202 of 2015 dated 30-06-2015; and

Whereas, some of the candidates figuring in the waiting list were found to have secured equal marks, in those cases preference has accordingly been given to the candidates who are older in age; and

Whereas, 29 selected candidates as mentioned in Annexure "A" to this order who could not be allotted the wings of their choice and preference due to non availability of vacancies in their preferred wing at the time of issuance of selection order and were just below the cutoff merit, have now been allotted the wing as per their preference in view of the vacancies accruing due to non joining of candidates in Executive

Police causing corresponding vacancies in Armed Wing in respective categories; and

Whereas, the nine candidates shown in Annexure "C" of this order who were earlier selected in their respective categories, were shifted to OM category due to their higher merit than the candidates of the waiting list (OM category), thereby creating nine vacancies in their respective categories; and

Now, therefore, taking into consideration the above facts, the candidates mentioned in annexure "B" of this order are hereby selected as Sub Inspector in J&K Armed Police from the waiting list subject to the following conditions/formalities:-

Verification/authentication of academic qualification certificates/other testimonials.

Verification of category certificate in respect of those ii. candidates selected under respective categories in pursuance of SRO-294 of 2005 dated 21-10-2005 read with SRO 144 of 2008 dated 28-05-2008.

Verification of Character/antecedents from CID.

Medical examination/checkup from respective Police Hospital Kashmir/Jammu.

The candidates selected shall report to ADGP Armed J&K along with their original testimonials within 21 days from the date of issuance of this order failing which their selection shall be deemed to have been cancelled abinitio.
