Subject: Selection of candidates after operation of waiting list for the post of Constables in 02 Border Battalions.

Whereas, in terms of PHQ order No. 668 of 2023 dated 27-02-2023, selection list in favour of 961 candidates as Constables in 02 Border Battalions was issued after completion of recruitment process and publication of select list year 2023.

Whereas, the candidates were subsequently adjusted in 02 Border Battalions for issuance of their formal appointment orders subject to fulfilment of prescribed formalities.

Whereas, the candidates selected in 02 Border Battalions were advised to present themselves in the offices of their respective places of adjustment alongwith requisite testimonials for fulfillment of prerequisite formalities prescribed for issuance of formal appointment orders within 21 days.

Whereas, directions were given to ADGP Armed J&K and Chairman PRB to intimate the reporting/non-reporting of selected candidates in their respective offices vide this

Headquarters communication No.PHQ/PRB-WB-BB/42/23/49663-65 dated 09-11-2023.

Whereas, in response to PHQ directions, ADGP Armed J&K and Chairman PRB have intimated that 49 candidates have not reported within stipulated time frame for joining indicating that these candidates are not interested to join the Police Department. Five candidates selected in various reserved categories failed to produce valid category certificates as claimed. Accordingly, the selection of 54 selected candidates was cancelled vide PHQ order No. 465 of 2024 dated 26-02-2024 on the recommendation of concerned quarters vide above referred communications. Further, character verification of one candidate was found adverse and accordingly his selection was cancelled vide PHQ order No. 460 of 2024 dated 23-02-2024.

Whereas, consequent upon the above, 55 vacancies have accrued as a result of cancellation of selection of 55 candidates.

Whereas, upon operation of the waiting list, two (02) of these 55 posts would remain unfilled in the districts of Samba and Bandipora due to non-availability of suitable candidates under RBA and EWS categories respectively.

Whereas, it has been further observed that 20 candidates having earlier been selected in their respective reserved categories as mentioned against each in Annexure "A" are either more meritorious i.e have secured more marks than candidates in the waiting list under OM category or are older in age to the OM category candidates in the waiting list who have equal marks to them. As such, these 20 candidates shall jump from their respective categories to OM category thereby causing equal number of vacancies in their respective categories.

Now, therefore, taking into consideration the above facts, 53 candidates out of the waiting list from respective categories as mentioned in Annexure "B" to this order are hereby selected as Constables in J&K Armed Police (02 Border Battalions) subject to the following conditions/formalities:-

- i. Verification/authentication of genuineness of academic qualification certificates of the selected candidates.
- ii. Verification of category certificate in respect of those candidates selected under respective categories in pursuance of SRO-294 of 2005 dated 21-10-2005 read with SRO 144 of 2008 dated 28-05-2008 and 127 of 2020 dated 20-04-2020.
- iii. Verification of Character/antecedents from CID.
- iv. Medical examination/checkup from respective Police Hospital Kashmir/Jammu.

The selected candidates shall report to ADGP Armed J&K alongwith their original testimonials within 21 days from the date of publication of this order for issuance of their formal appointment order failing which the selection shall be deemed to have been cancelled without any further notice.
