2.	Traffic Noses	Dimension: i) Height 42 inch. (ii) Length 48 inch iii) width 24 inch (iv) weight 15-20 kg iv) Colour Red with white strips .The product should be standard quality. Substandard material shall not be accepted

However, other contents & terms and conditions of the e, tender shall remain un-changed.


