Terms and Conditions / qualifying Criteria.

1.	The firm/association should be registered with the competent authority and should possess valid Goods and Service Tax registration and Permanent Account Number.
2	The rates quoted should be inclusive of all taxes / levies and other charges.
3	The model year of the vehicles should not be earlier than 2008 and in excellent running condition.
4	The vehicles should have valid RCs / fitness / pollution certificate from the competent authority
5	The vehicle should be comprehensive insured by the owner which should be valid at least for six month from the date of issue of rate contract.
6	The drivers of the vehicles should have valid commercial driving license.
7	The vehicles and their drivers should not be involved in any criminal case / subversive activity etc.
8	The Transporters/ Authorized dealers / Firm / Association will have to deposit an amount of Rs. 30.00 lacs (thirty lacs) as earnest money in the shape of CDR pledged to Accounts Officer ZPHQ Kashmir and in case of failure to provide requisite transport the same shall be forfeited as risk and cost money.
9	The Transporters/ Authorized dealers / Firm / Association should submit tax clearance certificate on the format prescribed by Income Tax Department.
10	No escalation in rates would be allowed during contract period under any circumstances.
11	The supplier is bound to keep sufficient stock of vehicles and at the time of exigency will have to provide the same without delay.
12	The Transporters/ Authorized dealers / Firm / Association blacklisted by any Government / Semi-Government Department / Corporation will not be eligible to participate in the bid process.
13	Transporters/ Authorized dealers / Firm / Association facing any case in a court of law are also not eligible to participate in the bid process.
14	Transporters/ Authorized dealers / Firm / Association must have valid TIN issued by J&K Commercial Tax Deptt.
15	Affidavit duly attested by 1 st class Magistrate to the effect that the tenderer has no past / present criminal record or any criminal case undergoing investigation trial within or outside the state.
16	The approved supplier / contractor shall provide details of vehicles proposed to be provided on hire, are to be indicated in the technical bid. In case of non availability for any reason of assigned vehicle for short durations, the contractor shall provide alternate vehicle equivalent to the regularly assigned vehicle or a better vehicle,

	but payments will be released with reference to the approved tender rates for the assigned types of vehicles, subject to the satisfaction of the Department that the alternate vehicle was equivalent to, or a better vehicle than, the assigned vehicle. If the approved supplier / contractor fail to provide alternate vehicle as above, the department is free to hire vehicles from any other source(s) at the risk and cost of the contractor.
17	All vehicles to be supplied should be registered as per Motor Vehicle Act with the competent authority duly and must possess up-to-date route permit for operation in J&K routes duly issued by competent authority and must carry comprehensive insurance cover.
18	The vehicle provided must be in excellent running condition, clean, with proper and complete documents required under rules, including registration certificate, valid insurance and road tax etc. documents should be shown to the user if asked for. All vehicles should confirm to all Govt. Rules and Regulations being in force from time to time.
19	Income tax and any other taxes as may be applicable from time to time during the contract period shall be deducted at source from the bills.
20	No advance payment shall be made under any circumstances.
21	The maintenance cost, road tax, permit fee, passenger tax, border tax, state tax, challan, salary of the driver etc are the responsibility of the contractor and no such payment shall be made by the Department.
22	The contractor shall be himself fully responsible for any loss or damage to the vehicle and liable for any claim of compensation by any third party.
23	Contract validity period: The contract rates shall remain valid upto 31.03.2019 from the date of issuance of contract.
24	Performance Security Amount:- The approved tenderer will have to supply the vehicles as per approved rate, approved specification, till the validity of the contract. They will have to furnish security deposit (performance security) equal in amount to 3% of the contract value in the shape of CDR from a Nationalized Bank, at the time of signing of Agreement/Deed to ensure satisfactory performance of the vehicles, supplied from the date of acceptance. This security deposit will be released in due course after the expiry of specified and agreed contract. The charges on stamps etc (cost of documents in totality) shall be borne by the supplier while executing the agreement. No interest shall be paid by the department on the security deposit.
25	Evaluation of Bids:- The department shall evaluate the financial bids of eligible bidders (those qualifying technical bids) to finalize the contract.
26	Solvency certificate from Bank.

27	Transporters/ Authorized dealers / Firm / Association whose EMD / Security is forfeited by any Government /Semi-Government / Corporation are not eligible for submission of tenders.
