If during the aforesaid period of 12 months, the said stores/ goods/ articles be discovered not to conform to the description and quality aforesaid or not giving satisfactory performance or have deteriorated, the decision of the purchaser in that behalf shall be final and binding on the contractor and purchaser shall be entitled to call upon the contractor to rectify/ replace the goods / stores/ articles or such portion thereof by the contractor and in such an event, the above mentioned warranty period shall apply to the goods/ articles/ stores rectified/ replaced from the date of rectification/ replacement thereof. In case of failure of the contractor to rectify or replace with the goods etc. within specified time, the purchaser shall be entitled to recover the cost with all expenses from the contractor for such defective stores by the available means.
