## TERMS AND CONDITIONS

1. The contract is valid till the Shri Amar Nath Ji Yatra 2018 is over or up to the date prior to this at the sole discretion of DGP (PHQ)/IGP Jammu.
2. Supplier firm should be registered with the competent authority. Applications/offers from un-registered firm will not be entertained.
3. The vehicles should be in good condition and well furnished. A list of all such vehicles which are being offered for hiring may be furnished along with all relevant details like make, model, type, registration No., Engine No., chassis No., year of manufacturing etc.
4. All vehicles offered for hiring should be of 2010 model or higher. No vehicle before 2010 model will be accepted for hiring.
5. The Driver of each vehicle should have a valid driving Licence and also have working mobile number.
6. Each vehicle should be registered with competent authority shall have all relevant documents required under rule like Insurance, Pollution free certificate, Fitness certificate etc.
7. Police department will not be responsible for any repair/maintenance/upkeep of vehicles. The supplier firm will be responsible for their repairs, maintenance, upkeep so that vehicles remain in good condition for all the time.
8. In case of breakdown of the particular vehicle during the contract period for any reason, alternate suitable vehicle/ substitute vehicle shall be provided by the supplier firm as immediate replacement. In case of failure to provide alternate vehicle in time, hiring charges shall be deducted on pro-rata basis for the down time and suitable penalty will also be levied.
9. In case of any accident/breakdown, the supplier firm shall be responsible for meeting of the claims and damages arising out of any such situation/accident.
10. Police department reserve all rights to accept/reject any application with out assigning any reason. Decision of Police department will be final in all respect.
11. No advance payment shall be made.
12. The supplier firm shall maintain a **Separate Log Book** in a form prescribed by police department in respect of each vehicle. All Log books should necessarily be verified and countersigned by the officer/official using the vehicle on daily basis. At the conclusion of Yatra or on de-hiring of vehicle, a certificate shall be recorded by the concerned unit to which the vehicle is deployed.
13. The Bills should be raised in triplicate at the end of the month and should be submitted to the Police department.
14. Department will deduct income tax at source under rules from the bills of the contractor.
15. The Supplier firm shall ensure that the hired vehicles remain available for full 24 hours.

For all the above mentioned terms and conditions, undertaking should be made on the Affidavit, attested by the Executive Magistrate and be submitted to this office for further course of action.
