## Short term Quotations

Short terms quotations, affixed with revenue stamp of Rs 5/- are, hereby, invited for the supply of following cables.

- a) Jelly cable 10 pair 0.61mm Copper conductor (unarmored) 7000 Mtrs Aprox.
- b) Jelly cable 05 pair 0.61 mm Copper conductor ( unarmored ) 5000 Mtrs Aprox
- c) PVC Cable 05 pair 0.61 mm Copper conductor 4000 Mtrs Aprox.
- d) Field cable 0.61mm copper conductor 10500 mtrs Aprox

1. Quotations are to be submitted on prescribed tender form which can be obtained on application from Police Telecom Headquarters J&K Jammu 1<sup>st</sup> floor APHQ complex Gulshan Ground Jammu on payment of tender fee of Rs 500/- in cash or money order which will not be refunded and same will be deposited in Govt. treasury under head 0055 Police.
2. Intending suppliers shall furnish Quotations, duly sealed and superscripted as "short term quotation for Cables" mentioning date of submission and name of supplier. The quotation shall contain following items.
  - a) Earnest money of Rs 25000/- pledged to Staff officer to IGP Telecom J&K Jammu
  - b) A copy of this Quotations affixed with revenue stamp of Rs 5/- duly signed and stamped on every page by the supplier in token of having understood and accepted the specifications, terms and conditions of the Quotations
  - c) CST certificate,
  - d) VAT clearance certificate up to March 2015

The quotations should reach this office on or before 4<sup>th</sup> of February 2016 up to 1030 Hrs. The Quotations so received will be opened on same date i.e 4<sup>th</sup> of Feb 2016 at 1500 Hrs in the office chamber of Staff officer to IGP Telecom J&K Jammu. In case of unforeseen circumstances the date of opening of Quotations received will be next working day.

3. Intending suppliers shall have to deposit earnest money of Rs 25,000/- in the form of CDR/FDR mentioned in the terms and conditions of the Quotation, without which quotations will not be considered. However, J&K Govt Rules with regard to furnishing of EMD in respect of Registered SSI unit shall be applicable in letter of spirit. The earnest money will be refunded to unsuccessful supplier within one month of the final acceptance of the tender.
4. Quotations received after the prescribed time and date will be rejected.
