Intending Tenderers shall furnish tender in envelope, duly sealed and superscripted giving NIT No. date and name of tenders containing Single sample of Data paper (which is must), Earnest money of Rs 25000/-, A copy of this NIT affixed with revenue stamp of Rs 5/- duly signed and stamped on every page by the tenderers in token of having understood and accepted the specifications, terms and conditions of the NIT, CST certificate, VAT clearance certificate up to March 2015 and should reach this office on or before **15th of Sept. 2015 up to 1030 Hrs.** The tender so received will be opened on **15th of Sept. 2015 at 1500 Hrs** in the office chamber of **Director Police Telecom J&K Srinagar**. In case of unforeseen circumstances the date of opening of tenders received will be next working day.
3. Intending Tenderer shall have to deposit earnest money of Rs 25,000/- in the form of CDR/FDR mentioned in the terms and conditions of the tender, without which tenders will not be considered. However, J&K Govt Rules with regard to furnishing of EMD in respect of Registered SSI unit shall be applicable in letter & spirit.
