Subject:- Rejection / Placement of candidates in open merit etc. due to non production of Original documents. 3 3

Reference:- PHQ J&K Advertisement Notice No. Pers-A-38/2016/59220-320 dated 08.10.2016. 2 3

Whereas, a total No. of 118217 application forms were received in response to above referenced PHQ J&K advertisement notice for filling up 5381 posts of Constables in J&K Police (Armed / Executive) under TRP-2016-17.

Whereas, all the eligible candidates desiring to appear in physical tests were required to bring along with original documents / testimonials for scrutiny on the day of their physical tests as per the instructions contained in the above quoted PHQ J&K advertisement notice.

Whereas, after the culmination of physical tests in all the Districts of J&K State, numerous candidates were found to have been deficient in respect of their original documents who were given an opportunity to produce their original documents in support of their claim with respect to Age / Residence/ Qualification and Reserved Category (if any), at PHQ Jammu /Srinagar (PRB Section) and SSP office Leh / Kargil till 05.07.2017 vide this office communication No. PHQ/ PRB-CTS/2017/395-409 dated 13.06.2017.

Whereas, inspite of having been given an opportunity for 20 days to make good their deficiencies, only some of the candidates turned up to produce their original documents. The Police Recruitment Board, in the larger interest of candidates decided to give them one final chance to all such candidates who could not make good their deficiencies. The left out candidates, as such were given a final chance to produce their original documents w.e.f 29.07.2017 to 04.08.2017 at PHQ (PRB section) Srinagar / Jammu vide this office notice No.PHQ/PRB-CTS/2017/470 dated 27.07.2017.

Whereas, after having been given final chance for clearing their deficiencies, 95 candidates were unable to produce their original documents in support of their claim with regard to Residence/Age/Qualification (Matric). The application forms of these 95 candidates whose details are mentioned in Annexure- "A" to this order are hereby declared to have been Rejected due to the reasons mentioned against each.

Whereas, during the scrutiny of documents, it has been found that 31 candidates have applied from Districts other than their Districts of domicile. As per the instructions contained in above referenced PHQ J&K advertisement notice, the candidates were required to apply for appointment from the District to which they originally belong (Based on Permanent Resident Certificate). Since the current recruitment for the post of Constable is to be made at District level, the application forms of these 31 candidates who are detailed out in Annexure-"B" to this order are hereby Rejected due to the reason that they have not applied from their District of domicile.


Whereas, as per the above quoted advertisement notice issued for the purpose, the eligibility criteria with regard to age for the candidates desiring to apply for the post of Constable was 18 to 28 years as on 01.01.2016. However, in case of serving SPOs / VHGs with a continuous period of engagement of minimum 03 years & 05 years respectively, the upper age limit was fixed to be 37 years. In case of Ex-servicemen, the upper age limit was fixed to be 48 years. During the scrutiny of documents, it has come to the notice of Police Recruitment Board that 65 candidates have not filled in actual dates of Birth (as per their Matriculation certificate) while submitting online application form. During the process of documentation, these 65 candidates were found either to have been overage or underage. Besides, 23 candidates were found to be non state subjects. As such, these 88 candidates (65 +23) whose details are given in Annexure- "C" to this order are declared as Ineligible for the said post due the reason mentioned against each.

Whereas, some posts out of the total 5381 posts have been reserved for different reserved categories as per the category wise breakup of posts detailed out in the above referenced advertisement notice. 1064 candidates failed to produce original documents in support of their claim regarding their reserved category as applied by them in online form despite having been given two opportunities for the said purpose. All these 1064 candidates whose application Nos are given in Annexure-"D" to this order are hereby placed in Open Merit due to non production of different category certificates.

Whereas, as per the contents of above referenced advertisement notice, a horizontal reservation to the extent of 15% & 4% shall be given to eligible serving SPOs and VHGs respectively provided SPOs & VHGs have completed continuous engagement of 03 years and 05 years of service respectively on the last date of submission of online application form i.e 20.12.2016. During the process of documentation, it has been found that some candidates after having applied under SPO/VHG/ Ex-serviceman category failed to produce original documents in support of their claim with regard to SPO/VHG/ Ex-serviceman category. The service details of such candidates who after having applied under SPO/VHG category qualified physical tests were got verified through their concerned Wings / Districts / units. As per the reports received from Wings/ Districts / Units, some candidates were found to have been deficient of their qualifying service as SPO / VHG. Besides, some candidates after having applied under Ex-serviceman category failed to produce valid documents in support of their being Ex-servicemen. All these 285 candidates whose details are given in Annexure- "E" to this order are declared to have been ineligible under SPO/VHG/ Ex-servicemen category and shall not be considered for horizontal reservation in SPO /VHG / Ex-serviceman category.

Whereas, the candidates were required to submit one online application form for appointment in one District only as per the instructions contained in the above referenced advertisement notice. After the culmination of physical tests, a list of all such candidates who have applied more than once was sought from the implementing firm i.e. M/S. SOS. As per the list submitted by M/S SOS through mail on 25.07.2017, 58 candidates were found to have submitted more than one online application forms either from same District or from different Districts.

The Police Recruitment Board after threadbare discussions on the issue decided to consider only one application form of such candidates. In light of the above, it is hereby ordered that only that application form of the candidate shall be accepted under which he / she has appeared in the physical test in the first attempt. The rest of the application forms in respect of these 58 candidates whose details are given in Annexure-"F" to this order are hereby rejected due to the reason that they have submitted more than one application form which contradicts the contents of the above quoted advertisement notice issued for the purpose.


