Subject:- Re-framing of selection list for the post of Constable (Photography) on State Level merit on court directions

- Ref'nce:-**

Whereas, aggrieved with their non-selection for the post of Constable (Photography) for which the selection list was issued by PHQ vide PHQ order No.1344 of 2012 dated 11.04.2012, 14 writ petitions were filed by 44 petitioners with lead petition SWP No. 875/2012 titled Sandeep Sharma and others VS State and others challenging the selection list inter-alia on the grounds that the selection was required to be made on State level merit instead of district wise merit;

Whereas, the Hon'ble High Court vide its order dated 20.04.2012 stayed the operation of the selection list as a result of which no further process vis-à-vis issuance of formal appointment orders could be taken up by the State respondents. The interim directions of the writ court were further upheld by the Division Bench of the Hon'ble Court vide its order dated 02.04.2013 passed in LPASW No. 30/2013 titled Sandeep Sharma and others VS State and others, stalling the process of issuance of formal appointment orders in respect of the selected candidates;

Whereas, the writ petitions came to be finally disposed of by the Writ Court through a common judgement passed on 15.07.2014, quashing the selection list issued by PHQ on District level merit, with further directions to the State respondents to re-frame the selection list on State level merit vis-à-vis J&K Reservation Rules 2005. The operative portion the court order dated 15.07.2014 is reproduced as under for ready reference:-

"For the reasons discussed, writ petitions are allowed and select list recommended by the DIG CID Kashmir(Chairman) vide No.DIG/CID(K)/12/85 dated 14.01.2012 and order No.1344 of 2012 dated 11.04.2012, according approval to select list, are quashed.

Respondents are commanded to reframe select list at State level on the basis of merit secured by candidates at State level, who participated in selection process having due regard to J&K Reservation Act, 2004, and J&K Reservation Rules, 2005, and thereafter consider candidates for appointment in order of merit against 82 posts of Constable in Photography cadre, though not mentioned in advertisement notice, but admittedly proposed to be filled up on finalization of selection process initiated vide advertisement notice dated 01.03.2011 and re-advertise such of the vacancies as are left unfilled. However, selection of such of private respondents, who find place in reframed select list and having regard to their place in the merit list and number of vacancies to be filled up, make grade for their appointment, shall remain intact and undisturbed..”

Whereas, on examination of the judgement at PHQ, the matter was referred to the Home Department vide PHQ letter No.Legal/SWP/29/J/2012/45424-28 dated 28.08.2014 for assailing the writ court order in the next higher forum and accord of sanction to the filing of LPA against the said Court order:

Whereas, the Home Department vide letter No.Home/PB-IV/130/2014/5400 dated 21.11.2014 has intimated that the Department of Law, Justice & Parliamentary Affairs have turned down the proposal for filing of the LPA and asked the department to implement the writ court order dated 15.07.2014 in letter and spirit:

Whereas, in light of the Court order dated 15.07.2014 and the advice of Department of Law, Justice & Parliamentary Affairs, a Committee of officers under the chairmanship of DIG Crime J&K was constituted vide PHQ order No. 203 of 2015 dated 24.01.2015 to scrutinize all the records relevant to the selection process of the Constable(Photography) particularly the selection proceedings forwarded earlier by the Board of officers constituted by PHQ vide order No. 3281 of 2011 dated 14.10.2011 and come up with recommendations for re-framing the selection list on State level merit with due weightage to the eligible candidates belonging to various reserved categories in terms of SRO-294/2005 dated 21.10.2005;

Whereas, the Committee has forwarded its report vide No. CHQ/CS-II/2015/325 dated 22.04.2015 alongwith recommendations for selection of 82 candidates to the post of Constable(Photography) in terms of the aforesaid Court directions vis-à-vis Reservation Rules 2005 as per the following break-up, subject to the final outcome in review petition filed by one Javaid Mansoor Rather and others against the single bench order dated 15.07.2014:-

In light of the recommendations of the Committee as enumerated above, approval is hereby accorded to the selection of the candidates named in the list forming Annexure "A" to this order as Constable Photography in J&K Police. The candidates belonging to Kashmir province shall report to SSP Crime Branch Kashmir while as candidates from Jammu province shall report to SSP Crime Branch Jammu alongwith their original testimonials for issuance of formal appointment orders, subject to the following conditions/ formalities:-

- a) verification/ authentication of the genuineness of the minimum academic qualification certificates including date of birth certificate of the selected candidates;
- b) verification of category certificates in respect of those candidates selected under reserved categories in pursuance of SRO-294/ 2005 dated 21.10.2005 read with SRO-144 /2008 dated 28.05.2008;
- c) verification of character/ antecedents from CID
- d) Medical examination/check from respective Police Hospitals Kashmir/ Jammu

IGP Crime J&K shall issue orders regarding adjustment of the appointees in Crime Branch Kashmir/ Jammu against vacancies in these units whileas in case of surplus candidates, if any, to be adjusted in Railways against existing vacancies of Constable(Photography)there, a proposal shall be referred by the IGP Crime to PHQ for further appropriate orders. He shall personally monitor early completion of the whole process in a time bound manner.

The appointees shall be deputed to basic recruit training course for which the matter shall be processed separately at PHQ. The inter-se-seniority in respect of those found fit for appointment shall be determined on the basis of aggregate merit obtained by them in selection as well as merit they may obtain in the basic recruit training.

Due representation has been given to the candidates belonging to various reserved categories in terms of SRO- 294/2005 dated 21.10.2005 read with SRO-

144/2008 dated 28.05.2008. In addition, SPOs confirming to the prescribed parameters have been given due weightage in accordance with the Rehabilitation Policy issued by the State Govt vide No: Home/PB-III/62/G/2008 dated 25.09.2009.

The select list is issued without prejudice to writ petitions, if any, pending before the Hon'ble High Court J&K.






