

Add (02) Advance increments @3% (Non compounded)	210+210 = 420
Initial pay fixed as on 01.01.2006	5200+420+5620+1800 = 7420

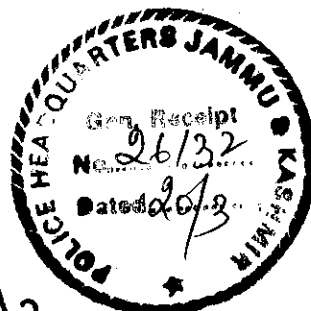
