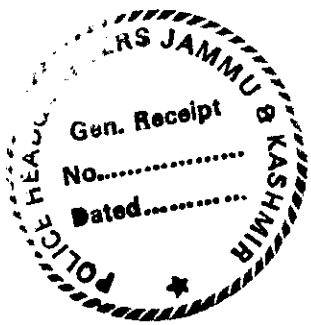
Vide PHQ J&K Jammu's Order No. 2582 of 2017 dated 31.07.2017, issued under Endstt. No. Pers-M-516/2001/55845-48 dated 31.07.2017 and subsequent directions from ZPHQ Jammu vide No. PS/S-03/2015/1483-86 dated 02.08.2017, SPO Kes Raj No.398/SPO S/O Jameet Ram R/O Samaie Tehsil Bhalessa District Doda was approved for his appointment as Follower in J&K Executive Police, on operational grounds, subject to the fulfillment of prerequisite formalities and CID verification.

The aforementioned PHQ order, together with genuineness of the same so issued by PHQ J&K, vide letter No. Pers-M-516/2001/64872 dated 08.09.2017 was received in this office, with the direction to issue formal appointment order in favour of the above named SPO as Follower, after completion of all prescribed/requisite formalities, including CID verification.

The CID verification in respect of the SPO was received from CID Hqrs. vide letter No. CID/VB/2017/Final/36153-Pol dated 27.11.2017, which reveals that there is nothing adverse against him. He was also got medically examined by the prescribed Medical Board, and the Board, through Medical Superintendent, Police Hospital Jammu; vide letter No. PHJ/M-1/2017/4138 dated 07.10.2017 has declared him medically fit for above mentioned Govt. service.

The date of Birth of the SPO is 15.09.1973 (Fifteen of September NH & seventy three) as per 8<sup>th</sup> pass School leaving Certificate issued by Govt. Girls High School Gowari Gandoh.



physical standard meant for the Follower. Others documents so produced by the SPO viz. state subject certificate etc have also been examined.


Therefore, in pursuance of aforementioned PHQ order and subsequent directions from ZPHQ Jammu, **SPO Kes Raj No.398/SPO S/O Jameet Ram R/O Samaie Tehsil Bhalessa District Doda** is hereby provisionally enrolled as Follower in J&K Police (trade Cook), in the pay scale of Rs. 4440-7440+1400 Grade Pay as per SRO-266 dated 31.08.2009 w.e.f. the date he physically joined at DPL Doda. 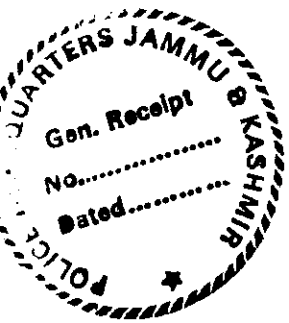




