**Subject:-**Release of promotion in respect of Ministerial Executive Cadre.

**ORDER NO : 727 OF 2018**

**Whereas**, among others, SI (M) Mohammad Shafi No.MEG931976 was also considered for being brought on promotion List "F" of the Cadre by DPC in its meeting held at PHQ on 29.12.2017.

**Whereas** after examining service records vis-à-vis clearance certificates from Vigilance Organization and CIV PHQ, DPC observed that although the candidate obtained the requisite minimum qualifying marks along with others for release of promotion to the rank of Inspr(M), but owing to the non communication of clearance or otherwise by State Vigilance Organization, the DPC decided that the proceedings in respect of the subject be kept in "sealed cover" and reviewed only on receipt of clearance from SVO.

**Whereas**, the State Vigilance Organization vide letter No. VO/40-08/NOO-2017-Police-692 dated 11.01.2018 has now cleared the subject.

**Whereas**, On receipt of report from Vigilance , the sealed cover proceedings were opened by the DPC and given to the clarifications as referred to above vis-à-vis recommendations of the DPC, SI (M) Mohammad Shafi No.MEG931976 who has obtained qualifying marks is brought on promotion list "F" of the Cadre for the year 2017 in continuation of PHQ order No.4678 of 2017 dated 29.12.2017 and accordingly promoted to the rank of Inspr (M) in the Pay Band-2 of 9300-34800+ GP 4280 with effect from 29.12.2017 i.e. the date his batch mates have been promoted as such. He is adjusted in Security Wing.

Note:- In the seniority list, SI(M) now Inspr (M) Mohammad Shafi No.MEG931976 shall figure below Inspr (M) Shakeel Ahmad NO. MEG911789 and above Inspr (M) Samima Aijaz No.MEG941447.

This order issues without prejudice to writ petition(s), if any pending in any competent court of law.


