Whereas, among others, HC (M) Yog Raj No.MEG992554 was also considered for being brought on promotion List "D" of MEC Cadre by DPC in its meeting held at PHQ on 29.12.2016.

Whereas, after examining service record vis-à-vis reports from Vigilance Organization and CIV PHQ, DPC observed that although the candidate obtained requisite minimum qualifying marks along with others for promotion to the rank of ASI(M), but owing to the pending finalization of Departmental Enquiry into his conduct as communicated by APHQ vide letter No. APHQ/, the DPC decided to keep the proceedings in respect of the subject in "sealed cover" till clearance from Armed Police Headquarters.

Whereas, the IGP Armed Kashmir vide letter No. AROK/GB/Mec/2017/13351-53 dated 23.11.2017 has now intimated that Enquiry ordered by APHQ vide order No. 873 of 2016 dated 24.12.2016 has been finalized vide AROK order No.415 of 2017 dated 07.11.2017, whereby the subject among others has been warned to remain careful in future. It has also been certified vide above referred to letter dated 23.11.2017 that the official is not involved in any criminal case/departmental enquiry nor any complaint is pending against him at present.

Whereas, On receipt of report from IGP Armed Kashmir, the sealed cover proceedings were opened by the DPC and given to the clarifications as referred to above vis-à-vis recommendations of the DPC, HC (M) Yog Raj No.MEG992554 who has obtained qualifying marks is brought on promotion list "D" of the Cadre for the year 2016 in continuation of PHQ order No.3994 of 2016 dated 31.12.2016 and accordingly promoted to the rank of ASI (M) in the Pay Band-2 of 9300-

34800+ GP 4200 notionally with effect from 31.12.2016 i.e. the date his immediate juniors have been promoted as such vide PHQ order No3995 of 2016 dated 31.12.2016. However, he shall be entitled for monetary benefit on account of this promotion with immediate effect. Consequent upon his promotion as ASI(M), he is adjusted in Jammu Zone against clear vacancy..

Note:- In the seniority list, HC (M) Yog Raj No.MEG992554 now ASI (M) shall figure below ASI (M) Ishtiyaq Ahmad NO.MEG992500 and above ASI(M) Satish Kumar No. MEG997304

This order issues without prejudice to writ petition(s), if any pending in any competent court of law.


