ORDER NO 3221 of 24

Sub: Selection of candidates after operation of waiting list for the post of Sub Inspector in J&K Police.

Whereas, in terms of JKSSB Notification No 01 Selection of 24, dt 08 Jan 24, selection list in favour of 1200 candidates as PSIs, in J&K Police, was issued after completion of recruitment process and publication of select list.

Whereas, the candidates were subsequently informed to report at their respective Range HQ for issuance of their formal appointment orders subject to fulfillment of prescribed formalities.

Whereas, the candidates selected were advised to present themselves in the offices of their concerned Range DIsG, along with requisite testimonials, for fulfillment of prerequisite formalities, prescribed for issuance of formal appointment orders, within 21 days.

Whereas, directions were given to all Range DIsG of UT of J&K to intimate reporting/non reporting of selected candidates in their respective offices, vide this HQ communication no PHQ/PRB-SIs/02/2024/12529, dt 24 Apr 24.

Whereas, in response to this HQ's directions, all Range DIsG of UT of J&K intimated that after having been selected 17 candidates expressed unwillingness, in writing, to join the department as they had been selected elsewhere. Besides, 06 candidates failed to join the Police Department within the stipulated time frame.



Moreover, 02 candidates were not recommended by the review committee in its meeting held on 09 Mar 24, at CID HQ.

Whereas, in response to Govt of J&K Home Department lr no Home-NGiv-51/2021/CC-27866, dt 03 Jun 24, category wise vacancy position accrued due to non joining of 25 selected PSIs was submitted to the Home Department J&K, vide PHQ lr no PHQ/PRB-SIs/01/2024/17768, dt 27 Jun 24, for its onward submission to JKSSB for drawing up of the waiting list.

Whereas, JKSSB, vide lr no JKSSB-Scry/26/2023-03(E-7376857), dt 30 Jul 24, notified the waiting list in respect of 75 candidates against 25 vacancies, to the extent of 1:3 of the vacancies available. Subsequently, JKSSB, vide lr no JKSSB-Scry/26/2023-03(E-7376857), dt 13 Aug 24, forwarded the above said waiting list to the Govt of J&K Home Department, for further action.

Whereas, Govt of J&K Home Department, vide lr no Home-NGiv/51/2021/CC-27866, dt 14 Aug 24, forwarded the said waiting list to this HQ, with directions that while operating the waiting list the ongoing litigations/ contempt petitions on the subject, viz OA no 714/24 titled Bilal Ahmad Vs UT of J&K & Ors; OA no 71/24 titled Umar Yousuf Vs UT of J&K and Ors and OA no 72/24 titled Barkat Rashid Pir Vs UT of J&K and Ors shall also be taken into consideration.

Whereas, in addition to the above, 03 more OAs, bearing no 502/24 titled Abid Hussain Peer Vs UT of J&K & Ors; no 66/24 titled Malook Singh Vs UT of J&K & Ors and OA no 36/24 titled Fouzia Kouser Vs UT of J&K & Ors have been received from Hon'ble CAT Bench Srinagar/Jammu, through Home Department, with directions to take appropriate action in the matter strictly in accordance with the rules governing the subject.

Whereas, Hon'ble CAT Bench Srinagar/Jammu while hearing OA no 714/24 titled Bilal Ahmad Vs UT of J&K & Ors; OA no 71/24 titled Umar Yousuf Vs UT of J&K and Ors; OA no 72/24 titled Barkat Rashid Pir Vs UT of J&K; OA no 502/24 titled Abid Hussain Peer Vs UT of J&K & Others; OA no 66/24 titled Malook Singh Vs UT of J&K & Ors and OA no 36/24 titled Fouzia Kouser Vs UT of J&K & Ors passed orders dt 12 Jul 24, 06 Feb 24, 13 Feb 24, 14 Aug 24, 30 Jan 24 and 18 Jan 24, directed the respondents to keep 06 posts of PSIs (01 under OM, 02





under RBA category and 03 under EWS category) reserved till the outcome of the said OAs.

Whereas, accordingly the selection of 23 selected candidates who had either shown unwillingness to join the department or failed to join, within the stipulated time has been cancelled, vide this HQ order no \_\_\_\_\_ of 24 dt \_\_\_\_\_ Nov 24.

Whereas, in terms of this HQ lr no PHQ/PRB-PSIs-20/2024/23548, dt 02 Sep 24, the Home Department, was informed about the vacancy position of SIs in various categories, which were to be utilized for operation of waiting list.

Whereas, with regard to operation of waiting list, the Home Department vide lr no HOME-NGiv/51/2021[CC-27866], dt 26 Sep 24, conveyed that the matter was referred to the Social Welfare Department, who vide UO lr, dt 18 Sep 24, replied as under:

*"The Department has examined the matter thoroughly and it is to say that the original selection list and the candidates who have been selected under it and have joined is a closed chapter; and therefore cannot be modified. The waiting list is to be treated as a new selection list and is unrelated to the original one. Candidates who were selected under reserved categories and have joined their respective reserved categories cannot be shifted to Open Merit, even if their merit is higher than those on the waiting list. Such a shift would lead to an endless selection process and impact the seniority established in the original list.*

*The Home Department is advised to proceed accordingly."*

Now, therefore, taking into consideration the above facts, 19 candidates (14 candidates under Open Merit, 01 under EWS and 02 each under ST and SC category) out of the waiting list as mentioned in Annexure "A" to this order are hereby selected as PSIs in J&K Police subject to the following conditions/formalities:

- i. The selection list after the operation of waiting list shall be subject to outcome of the OAs/Writ Petitions(s), if any, pending adjudication before any competent court of law.
- ii. The waiting list shall also be subject to the outcome of any inquiry, involving candidates(s) figuring in the selection list.
- iii. Verification/authentication of genuineness of testimonials of the selected candidates.



- iv. Verification of category certificate in respect of those candidates selected under respective reserved categories.
- v. Verification of character/antecedents from CID.
- vi. Medical examination/checkup from respective Police Hospitals Kashmir/Jammu.

The selected candidates shall report to their concerned Range DIsG along with their original testimonials within 21 days from the date of publication of this order for issuance of their formal appointment order failing which the selection shall be deemed to have been cancelled without any further notice.
